During his tenure, he argued 10 cases in the U.S. Supreme Court involving issues of administrative law, employment discrimination, patents, federal taxation, debt collection, criminal law, immigration, and Medicare reimbursement. While in government, he prepared briefs in more than 180 Supreme Court cases involving a diverse range of federal issues, including many with substantial administrative law components, and advised the Solicitor General regarding appellate strategy in numerous matters in lower courts nationwide. Before that, Bond was a partner in Gibson Dunn's D.C. office, where he practiced from 2010 to 2017. He served as a law clerk to U.S. Supreme Court Justice Antonin Scalia from 2009 to 2010, and prior to that clerked for Judge Jeffrey S. Sutton of the U.S. Court of Appeals for the Sixth Circuit from 2008 to 2009. Bond graduated first in his class in 2008 from The George Washington University Law School, where he was elected to the Order of the Coif and served as senior articles editor for *The George Washington Law Review*.
